Strengthened transparency obligations regarding the UBO's identification: what are the impacts for the non-profit sector?

The Belgian law on the prevention of money laundering and terrorist financing and the limitation of use of cash of September 18, 2017 (hereafter: “Anti-Money Laundering Law”) has entered into force on October 16, 2017. The Anti-Money Laundering Law has transposed the Fourth EU “Anti-Money Laundering Directive” of May 20, 2015 whose main objectives are to reinforce the current rules and to fill the regulatory gaps to prevent criminals and terrorists to find ways to finance their illegal activities and to launder the financial gains thereof back into the economy.

Insolvency reform and its impact on associations: what you need to know

On 11 August 2017, the Belgian Parliament adopted a bill containing an entirely new insolvency legislation (the “Insolvency Bill”). The Insolvency Bill will be integrated into the Belgian Code of Economic Law and will constitute its Book XX, called “insolvency of undertakings”. The Insolvency Bill will enter into force on 1 May 2018. Complete version soon on FAIB's website.
