The (B2B) law of 4 April 2019 introduced rules on unfair clauses in the Code of Economic Law. In a judgment of 23.01.20, the Constitutional Court ruled that the exemption for patrimony tax on immovable property located abroad cannot be justified and is contrary to the constitutional principle of equality. Antoine Druetz, Partner & FAIB Associate Member, Sofie Van Doninck, Partner and Filip De Scheemaeker, Senior Manager at EY Tax Consultants, explain in details to FAIB members the implications of said law.
