Le 23 septembre, lors de l'ouverture du débat annuel de l'AG de l'ONU, le Vice-Premier ministre Steven Vanackere a traité de la gouvernance dans les organisations : « la gouvernance, ce n'est pas seulement être responsable, c'est aussi être transparent », a-t-il déclaré, plaidant pour le renforcement des instruments de protection des droits de l'homme. La citoyenneté européenne : le renforcement de l'Union en tant qu'espace de liberté, de sécurité et de justice :

Contribution de la FAIB à la consultation des DG Justice et Home Affairs de la Commission Européenne.

La FAIB a souhaité mettre l'accent sur les associations internationales dans sa réponse à la consultation. Mettant en évidence la faible réactivité des citoyens aux initiatives européennes, elle a souligné le rôle des associations comme relais pour porter la voix des délégations multinationales des associations vers la Commission et pour convoyer le message européen en retour vers les citoyens. Représentant des intérêts très divers, les associations ont des axes variés sur lesquels elles attendent des progrès dans l'espace européen : les coûts des transactions ou l'établissement de

standards... pour les groupements économiques ou la participation démocratique et les droits de femmes... pour les humanitaires ou encore la protection des consommateurs et le statut des chercheurs... pour d'autres encore. La FAIB réclame que la voix des associations soit entendue lors des actions d'évaluation du programme. Enfin, elle a recommandé d'intégrer fortement le Parlement européen dans l'action et de prendre en compte, au-delà des droits individuels des citoyens, les droits communs sur les biens collectifs.

VAT aspects: more clarifications by Alain Soriano, Belgian VAT Desk (as@vatdesk.be)

A workshop took place at the FAIB on 29 September. Mr Brent Springael (Bird & Bird) facilitated the debates. The meeting generally supported to withhold a possible contact with authorities until a clearer view of the political situation is available. It recognized that the main issue is now at the level of the associations' members within the EU that either do not have a VAT number or are officially exempt in their country and need the support of their Belgium-based association to certify their fiscal status with Belgian tax authorities.

Our Associate member, Alain Soriano provided a more detailed explanation of this rather intricate issue:

"According to the new VAT package, associations are obliged to verify the VAT status of their members and the fee invoicing transaction. In case the service is taxable in the EU member's country, the association must issue the invoice without VAT provided that the member activates and communicates its local VAT number and that the association reports the transaction in box 44 of its VAT return as well as in the intra-community listing.

If the service is exempted in that country, there is no VAT; the member does not activate a VAT number; the transaction is reported in box 47 but not in the intra-community listing".

The European transparency Initiative. Where does it stand ? Where does it go ?

At the lunch debate of 9 September, FAIB was pleased to welcome Dirk Lontings, lawyer and FAIB Associate member on the topic that, since 2005, draws the attention of the estimated 15.000 NGOs, trade associations, corporations and other interest groups seeking to influence EU policymakers.

He stressed on two items of particular interest for FAIB members:

1. The reluctance of lawyers to register and the secrecy of their professional relationships as the registration of lobbyist requires disclosure of their clients' names and financial data relating to them. If EU registration would become compulsory (like in the US), lawyers would no longer be able to serve clients like trade associations. Lontings tackled the issues of the legal scope of professional secrecy, the possible attitude of the Court of Justice and the actual willingness of the Commission to render registration mandatory. He commented on the Directives 77/249 and 98/5 stipulating that lawyers must respect the Codes of Conducts of their home and host Member States.
2. In the second part of his presentation, Lontings expressed his surprise that many trade associations and NGOs seem unaware of the existence of the EU legal framework giving an access right to European Parliament, Council & Commission documents. He gave the legal references and explained the three avenues that are possible to have access to this material.
