### **Key Success factors for International Associations:** FAIB Lunch Debate 14.6.2012 by Mr Mark Dober.

Representing Ellwood & Atfield – [www.ellwoodandatfield.com](http://www.ellwoodandatfield.com), a specialist executive search firm focused on communication and public affairs, the speaker commented a survey consisting of interviews of high level officers of international associations to identify key factors that make associations successful.

He pointed out 4 reasons, each of them split in a number of sub-elements: leadership and good governance, consensus between members, communications that tend to be downgraded and the added-value of the body. As special comments, we had a view on the 7 criteria that allow assessing the role of the DG and the way he fulfills his mission, and the criteria to be used by members to measure the efficiency of their European representatives.

### **Assemblée générale: Discours du Vice-Premier Didier Reynders**

Dans un exposé brillant et clair, **M. Reynders** donne un panorama des principaux chantiers de son département des Affaires étrangères : Afghanistan, Afrique Centrale, Syrie et Iran.

Il développe les problèmes de la zone Euro et plaide, au-delà des Euro bonds, pour un transfert complémentaire de compétences vers le centre de l'UE pour une harmonisation des politiques budgétaires.

Pour Bruxelles, souvent perçue à l'étranger comme une entité en soi, il épingle les efforts faits pour les infrastructures (Conseil des Ministres, OTAN, Zaventem, Centre de Congrès), mais il met l'accent sur l'accueil des travailleurs et visiteurs étrangers, les réseaux pour une action cohérente et l'environnement.

A des questions de l'auditoire, il donne des pistes intéressantes pour l'efficacité et la simplification de l'action des associations internationales.

### **VAT applicable to INPA's from the VAT Desk Flash 510 February 2012.** ([www.vatdesk.be](http://www.vatdesk.be))

Fiscal authorities appear extremely strict on compliant invoices. By January 2013, a new Directive will harmonize rules throughout Member States. The changes will notably affect the following:

- one single competent Member state to determine the VAT obligations in order to ensure a better legal certainty (the fear is that this obligation will end up in some cases to grotesque situations);
- uniform mandatory mentions: an exhaustive list of requested data;
- invoicing deadlines for B2B services: at the latest, the 15<sup>th</sup> day after the taxable event occurred.

The BELGIAN VAT DESK recommends being more vigilant than ever; FAIB will soon re-activate its VAT workgroup to share the experiences of its members and assess the way forward (see below).
